BIOGRAPHICAL NOTE

Lloyd R. Shoemaker (1921-1995) was born in Salt Lake City, Utah, and enlisted in the U.S. Army in March 1941. He served in the China-Burma-India Theater where he was captured and held for a short time as a prisoner of war. He escaped his captors and was assigned to the Military Intelligence Service (MIS-X) in Alexandria, Virginia, where he remained through the end of World War II.

After the war, Shoemaker became a police officer in Salt Lake City and served as director of the Veterans of Foreign Wars Emergency Services Corps, which conducted rescue operations for the state. He was also an insurance investigator, a building contractor, and a rancher, and he served as the building official for the city of Kalispell, Montana, where he retired in 1982. Upon his retirement, Shoemaker wrote a book about MIS-X activities called *The Escape Factory*, which was published in 1990. Shoemaker was a member of the Disabled American Veterans and an honorary member of the Stalag Luft III POW Association. He donated his research materials to the Air Force Academy shortly before his death in 1995.

The Military Intelligence Service-X Section (MIS-X) was a top-secret classified section of the United States Department of War that was established to handle U.S. personnel trapped or held captive by the enemy during World War II. Its functions included training airmen in escape/evasion techniques and proper conduct if captured. The department was also tasked with gathering intelligence information from returning POWs and escapees, including the location of enemy camps, enemy interrogation techniques, the location of local escape networks, and the identification of enemy collaborators. MIS-X established and disseminated codes to airmen so that, if captured, they could transmit information about the enemy in his letters home. MIS-X also planned and facilitated the rescue of American POWs and others who were trapped behind enemy lines. MIS-X operated in all theaters of the war and is credited with assisting some 16,000 U.S. personnel with their return to Allied territory.

Additional information regarding Shoemaker and MIS-X can be found in his book *The Escape Factory* (included), and in other documents within the collection.

SCOPE AND CONTENT NOTE

The Shoemaker Collection consists of a primary collection of six boxes, plus an additional seven addendums that were acquired by Clark Special Collections at later dates. Those addendums are included at the end of this finding aid. This material was assembled by Lloyd R. Shoemaker during research for his book *The Escape Factory*, copies of which can be found in Addendum 4. Some items were removed from the collection at an earlier date and sent to the Office of the Secretary of the Air Force in Washington, D.C. A list of these items may be available upon request.

Scope and content information for each individual addendum can be found within those sections of the finding aid. The primary collection, SMS 576, consists of nine series divided among six boxes, outlined below.

Note on POW camp names: For clarity and electronic search purposes, the names of the prison camps in this document have been standardized. Roman numerals have been replaced by numbers, and hyphens have been removed. For example, the POW camp popularly known as "Stalag Luft III" is referred to as "Stalag Luft 3" in this document. Additional examples include "Stalag 7A," "Stalag 2B," and "Oflag 64." The names of Italian POW camps are numbered, and prefixed with the initials "P.G.," which stands for Prigione di Guerra (Prison of War). Examples include "P.G. 54" and "P.G. 60."

SERIES ONE: MIS-X INDEX CARDS

Shoemaker's index file that he produced for use in his own research. These cards list and sometimes summarize MIS-X files in Series 2, as well as EX Reports, Escape and Evasion (E&E) Reports, and Repatriation Reports located in Series 3-5 of this collection. Additional index cards can be found in Addendums 2 and 7.

SERIES TWO: MIS-X OPERATION AND COMMUNICATION

Consists of MIS-X operational documents and communications produced between 1942 and 1949. The six files in this series are separated by year and include numbers from an unidentified source.

SERIES THREE: EX REPORTS

EX Reports were produced by members of MIS-X's CPM branch (Captured Personnel and Material), who interviewed American airmen that successfully evaded capture, escaped imprisonment, or were liberated from enemy camps. Information gained from these interviews was used to ascertain the value of the training and tools they were provided, for the training of additional forces, and to help plan future rescue missions into enemy territory. These reports provide names, squadron information, assignments, crash locations, prison camp locations, and methods of escape. These reports also provide much more detailed information regarding enemy transportation, prison camp conditions, procedures for searching prisoners, access to parcels, escape lines, and more.

Each EX Report was assigned an "EX Report Number," which is unique to each person being interviewed. These interviewees escaped, evaded, or were released between 1942 and 1945. These incidents occurred in enemy territories across Europe and Asia including Italy, Germany, Poland, Austria, Bulgaria, Romania, the Channel Islands, Guam, the Philippines, Myanmar (Burma), China, and Russia (USSR). Additional EX Reports are located in SMS 576-Addendum 7, Series Three.

SERIES FOUR: ESCAPE & EVASION REPORTS (E&E REPORTS)

Like the EX Reports in Series Three, E&E Reports were produced by members of MIS-X who interviewed American airmen that successfully evaded capture or escaped imprisonment. Each E&E Report was assigned an "E&E Report Number," which is unique to each person being interviewed. These incidents occurred in enemy territories across Europe including Italy, Germany, France, Poland, Austria, Hungary, and Yugoslavia. These reports provide information nearly identical to that of the EX Reports in Series Three.

SERIES FIVE: REPATRIATION REPORTS (R REPORTS)

Like the reports in Series Three and Series Four, Repatriation Reports (R Reports) were produced by members of MIS-X who interviewed American airmen that successfully evaded capture or escaped imprisonment. Each Repatriation Report was assigned a "Repatriation Report Number," which is unique to each person being interviewed. In each case the Repatriation report states that the individual was repatriated from Germany. These reports provide information nearly identical to that of the reports in Series Three and Series Four.

SERIES SIX: MAPS AND DIAGRAMS

One folder containing maps referencing the location of German Prison Camps, and specific diagram maps for Stalag 7A and Stalag Luft 3.

SERIES SEVEN: JAPANESE CIVILIAN AND POW CAMPS

Six files containing reports, communication, and other documents regarding the conditions at Japanese prison camps in India and Southeast Asia.

SERIES EIGHT: PUBLISHED MATERIAL

Consists of four folders containing published articles and books about MIS-X and the World War II POW experience.

SERIES NINE: MISCELLANEOUS
