BIOGRAPHICAL NOTE

Burton Curtis Andrus

Burton Curtis Andrus (1892-1977) attended the State University at Buffalo and worked for the Standard Oil Company of New York from 1910 until he was called to active duty through the Officer Reserve Corps (ORC) in 1917. By June 1942 he had advanced to the rank of Colonel, and by 1944 he was commanding officer of the 10th Traffic Regulation Group (TRG) and a Combat Observer for the G-3 (Operations) Branch, Headquarters, European Theater of Operations in World War II.

His most significant military duty, however, came after the war when Colonel Andrus served as Commandant of the 6850th Security Detachment. This unit was responsible for guarding the accused Nazi war criminals who were tried by the International Military Tribunal in 1946, also known as the Nuremberg Trials. After Nuremberg, Andrus served as attaché to Israel in 1950 and Brazil from 1950 – 1952, at which point he retired from military service. Colonel Andrus taught at the University of Puget Sound in Tacoma, Washington from 1955 – 1968 and was appointed Professor Emeritus in 1968. He was the author of two books; *The Infamous of Nuremberg*, and *I Was the Nuremberg Jailer*. His Military decorations include The Bronze Star, The Legion of Merit, Order of Leopold with palm, Croix de Guerre with palm (Belgium), Order of the Oak Wreath Crown (Luxembourg), and the Military Medal (Brazil).

International Military Tribunal, Nuremberg

The Nazi war criminals who were to be tried in Nuremberg were originally held at Central Continental Prisoner of War Enclosure No. 32, codenamed *Camp Ashcan*, between May and August 1945. Camp Ashcan was an Allied prisoner-of-war camp located in the Palace Hotel, a four-story luxury hotel in Mondorf-les-Bains, Luxembourg. The camp was commanded by Col. Andrus and staffed by men of the U.S. 6850th Security Detachment, Allied intelligence services, and 42 German prisoners of war including barbers, dentists, and doctors. The prisoners were transferred to the Palace of Justice in Nuremberg to stand trial in August 1945, and the camp was disbanded shortly afterwards. Between November 1945 and October 1946, the Tribunal tried 21 of the most important military and political leaders of the Nazi regime. It was here that the world first learned about the Nazi Party's horrific actions over the course of the war including details regarding the "Final Solution," the murder of POWs, the atrocities carried out in Nazi extermination camps, and many other cruel acts committed against Jews. As a result of the trial three Nazi prisoners were acquitted, seven were sentenced to prison, and ten were executed. One prisoner, Hermann Goering, committed suicide in his cell before he could be hanged.

SCOPE AND CONTENT NOTE

This collection consists of five boxes divided into five series, outlined below. These items relate to the military career of Col. Burton C. Andrus, the 6850th security detachment, and their role in the International Military Tribunal at Nuremberg. Their duties not only included guarding the prisoners at Camp Ashcan and at the Palace of Justice, but also *protecting* the prisoners from harm, interviewing tribunal witnesses, providing psychological profiles of the prisoners, providing basic necessities to the prisoners, and providing security and administration services for the trial itself. The materials in this collection document their performance of these duties.

SERIES ONE: PERSONAL RECORDS OF BURTON C. ANDRUS

Series One includes official orders and reports pertaining to the administration of Camp Ashcan and the Palace of Justice.

SERIES TWO: 6850th SECURITY DETACHMENT DAILY OPERATIONS

Series Two includes information regarding standard operating procedures, progress reports, and personnel documents of the 6850th Internal Security Detachment.
