### **BIOGRAPHICAL NOTE**

This collection was donated by Barbara Powers Wyatt, editor of the book *We Came Home: POWs of Viet Nam*, which was published in 1977. She acquired and assembled these materials through her correspondence with hundreds of Vietnam prisoners of war, whose biographies are included in this book and in the contents of this collection.

### **SCOPE AND CONTENT NOTE**

This collection consists of twenty boxes divided into five Series. Series One, by far the largest of the five, contains 470 files each containing information on individual Vietnam prisoners of war. Each file includes letters, photographs, and narratives written about each subject and their experiences as soldiers and prisoners. Each is a mix of original materials and photocopies, which were produced either at the time the events occurred or shortly thereafter, prior to the publication of Dr. Wyatt's book in 1977. Series Two consists of photographs that were not included in the individual files from the first series, but depict images of Vietnam POWs either in captivity or upon their homecoming. Series Three includes a small number of government documents that were included in the collection, and Series Four contains various documents produced by a POW support organization called the National League of Families (NLOF). Finally, Series Five consists of materials that were either published or intended to be published, including a copy of the book that was the culmination of Mrs. Wyatt's research.
